- RAYMOND SCULK SECRETARY Resolution authorizing the County of Westchester, acting by and through Westchester Re: Community College, to consent to the assignment of the agreement with New York State Industries for the Disabled ("NYSID"), and their subcontractor, American Maintenance, for the provision of janitorial services for Westchester Community College, to NYSID, with the subcontractor, Kellermeyer Bergensons Services, LLC, effective on or about August 1, 2021.

By a Resolution approved on May 28, 2020, your Honorable Board authorized the County of Westchester, acting by and through Westchester Community College (the "College") to enter into a contract with NYSID for janitorial services for the College for the period September 1, 2020 through August 31, 2025, with the subcontractor American Maintenance. The contract was subsequently executed.

By letter dated August 3, 2021, the College was notified that Kellermeyer Bergensons Services, LLC ("KBS") had acquired American Maintenance. The agreement with NYSID requires the County's consent to any assignment of the contract. Accordingly, authority is requested to consent to the assignment of the contract for janitorial services for the College from NYSID with subcontractor American Maintenance, to NYSID with the subcontractor KBS effective on or about August 1, 2021.

It should be noted that the College has conducted its due diligence by contacting a number of KBS's current customers, two of which are Westchester based universities.

The goal and objective of this contract is to provide a clean working environment for students, faculty, and staff by providing janitorial services for the College. The performance of KBS will be monitored by College staff to ensure that contractual obligations are met by KBS.

Accordingly, approval of the attached resolution is respectfully requested.
