On October 27, 2021, the County of Westchester ("County") received and opened seven (7) bids for Contract No. 18-526 for Twin Sludge Force Main Rehabilitation, Mamaroneck and New Rochelle, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that Gianfia Corp. submitted the low bid in the amount of \$9,458,460.00, and has proposed the utilization of the following subcontractor: West-Fair Electric Contractors, Inc. (Electrical Work), 200 Brady Avenue, P.O. Box 298, Hawthorne, New York 10532.

The low bidder has been investigated and it has been found that Gianfia Corp.:

The objective of this contract is to rehabilitate the twin sludge force main pipelines which transfer sludge from the Mamaroneck Wastewater Treatment Plant to the New Rochelle Wastewater Treatment Plant. This work is necessary to provide improved sanitary facilities that are in compliance with all applicable regulations. This project will implement the most cost-effective and environmentally compliant technologies available.

This contract is in the public's best interest because it enables the Westchester County Department of Environmental Facilities to conduct its basic mission of providing wastewater treatment and maintaining water quality, thereby enhancing the health and general welfare of the residents of Westchester County.
