On November 17, 2021 the County of Westchester ("County") received and opened six (6) bids for Contract No. 21-507 for Roof Replacement Program, Yonkers Joint Water Resource Recovery Facility, Yonkers, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that Nua Construction Corp., a WBE firm, submitted the low bid in the amount of \$2,814,000.00.

The low bidder has been investigated and it has been found that Nua Construction Corp.:

The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.
