.P. SECRETARY SECRETARY Resolution authorizing an agreement between the County of Westchester SUBJECT: and Mid-Hudson Pattern for Progress to provide professional services in connection with updating the County wide Affordable Housing Needs Assessment for all municipalities.

The attached resolution, if approved by your Honorable Board, would authorize the County of Westchester (the "County") to enter into an agreement with Mid-Hudson Pattern for Progress (the "Pattern for Progress"), to provide a grant from the Community Development Block Grant Program. The grant will be used to update the data profiles for all the municipalities in Westchester County. The amount of the grant is \$40,000.00, pursuant to an approved budget, and the term of the agreement is April 15, 2022 to April 14, 2023.

Pattern for Progress will provide their professional service again in updating the report they prepared in 2018. The County's Affordable Housing Needs Assessment requires periodic updates in an effort to get a current picture of the affordable housing needs within the County for federal grant applications and reports. This updated assessment will study the County's existing housing stock and its affordability, as well as the needs of Courty households using more current Census data, Fair Market Rents, Area Median Incomes and Medial Sales prices. Pattern for Progress will work closely with the County profiles for the local municipalities. to update the outdated components of the Affordable Housing Needs Assessment

The goal and objective of this agreement is to get an understanding of the housing needs in the County. The Department of Planning staff will monitor all work provided by Pattern for Progress to make sure all contractual requirements are met.

This procurement is in compliance with the County of Westchester Procurement Policy Procedures, pursuant to Section 3(a)xvi, which states that contracts with recipients for disbursement of grants or loans under the Community Development Block Grant Program are exempt.

Act # 20-2020, adopted March 9, 2020, by the Westchester County Board of Legislators, authorized the County to submit an Urban County Application under the Federal Community Development Block Grant, Emergency Solutions Grant, and HOME Investment Partnership Program, including a FY 2019-2023 Consolidated Plan and to accept such Grants.
