The 2022 Capital Budget contains funds for the above referenced project.

The work under this contract consists of providing all labor, material and equipment required for the rehabilitation of the Main Street Bridge over the Bronx River Parkway and Bronx River including, but not limited to, removal and replacement of the existing asphalt wearing surface, excavation, backfill and waterproofing, concrete and masonry repairs, subsurface drainage repairs, replacement of stone parapet walls, ADA ramps, traffic signal modifications, work zone traffic control guiderail, and fencing.

The objective of this contract is to replace substandard areas of asphalt paving.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that the roadway meets current codes and standards as well as reducing the County's aroual maintenance costs.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.
