The 2022 Operating Budget contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment required to provide Direct Digital Control System service for buildings located at the Grasslands Campus, White Plains Complex and various DPW maintained buildings throughout Westchester County. This contract is for a term of three (3) years with one two (2) year renewal at the discretion of the County.

The objective of this contract is to ensure that the Direct Digital Control System is operating within specified parameters.

This contract is in the public's best interest because it will promote the health and safety of the general public by maintaining heat and air conditioning within specified parameters.

As expenditures are made pursuant to this authorization, detailed records will be kept in the County's on-time financial system. These records will be easily accessible by Finance, Budget and department shaff and will be reviewed regularly to ensure that funds are used appropriately.
