SUBJECT: Approval of Change Order No. 2 to Contract 20-504 with Tully-Arben LLC for

Rehabilitation of Pool and Bathhouse, Playland Park, Ryc, New York in an amount not

to exceed \$475,000.00 increasing the total contract amount to \$21,273,848.00.

On February 4, 2021, your Honorable Board awarded Contract No. 20-504 for Rehabilitation of Pool and Bathhouse, Playland Park, Rye, New York to Tully-Arben LLC, 127-50 Northern Boulevard, Flushing, New York 11368 ("Tully-Arben") in the amount of \$19,878,848.00.

Subsequently, on February 10, 2022, your Honorable Board approved Change Order No. 1 to Contract No. 20-504 for Rehabilitation of Pool and Bathhouse, Playland Park, Rye, New York to Tully-Arben in an amount not to exceed \$920,000.00 increasing the total contract amount to \$20,798,848.00.

The scope of work of the base contract consisted of providing all necessary labor, material and equipment required for the reconstruction of the Playland Pool and the rehabilitation of the Playland Bathhouse. Work included all associated mechanical, electrical and site work.

The scope of work of Change Order No. 1 consisted of providing all necessary labor, material and equipment required for additional unforeseen sub-grade construction and debris removal.

During fit-out of the facility by the County's management company Standard Amusements LLC ("Standard"), it was determined that additional electrical and IT infrastructure was required in order for Standard's vendors to complete their installations. Provision by the County of this additional infrastructure is a requirement of the Second Restated and Amended Playland Management Agreement between the County and Standard. The work that the County is required to undertake pursuant to its agreement with Standard, is the type of work being performed by Tully-Arben under Contract No. 20-504 and must be done in the area where the contract work is ongoing. Specifically, the additional work to be performed under contract 20-504 included installation of electrical cabling, fiber optic cabling, in-wall electrical and data boxes along with installation of panel boards and their associated in-wall supports. This additional work needed to be coordinated and constructed simultaneously with the work of the base contract.

The cost of this additional electrical and IT infrastructure work is estimated to be \$475,000.00 and is based upon Tully-Arben's unit prices, which were reviewed and approved by the Department. The scope of work for this additional electrical and IT infrastructure work could not have been anticipated at the time of bid, and therefore a change order to contract 20-504 is hereby requested.

The objective of this contract is to maintain the weather tightness and structural stability of the Playland Bathhouse along with constructing a new zero-depth entry recreational swimming pool.

This contract is in the public's best interest because it will rehabilitate these historic structures which are integral contributing historic elements of Playland Park and help define Playland Park's landmark status.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project

This additional work is incidental to the original work and does not materially alter the main purpose of the contract as to constitute a new undertaking. The work is of the same nature as the initial work, is to be performed in the same general vicinity, is necessary to efficiently complete the project and was unanticipated until work under the contract began. The term of the contract is February 18, 2021 to October 28, 2023.

It is requested that your Honorable Board take action on the following:
