Please note that the Westchester County Minority/Women's Owned Business database was reviewed and there are no qualified MWOB firms currently registered to perform these types of specialty work.

Contractors' Line and Grade South, LLC is being requested to do Surveying. It should be noted that Gianfia Corp. additionally canvassed two (2) WBE firms: Badey & Watson Surveying & Engineering, P.C. and Chrysalis Archaeological Consultants, Inc. for Surveying; however, both firms responded as not interested.

Empire State Trucking Inc. is being requested to do Trucking & Hauling. It should be noted that Gianfia Corp. additionally canvassed K&D Industries of NY, LLC, a MBE firm, and Niko Construction & Trucking Services Inc., a MBE/WBE firm, for Trucking & Hauling; however, K&D Industries of NY, LLC's quoted price exceeded the budgeted amount for the type of work being requested, and Niko Construction & Trucking Services Inc. did not respond to Gianfia Corp.'s inquiry.

The listed Subcontractors have been investigated, and the Department recommends approval.
