SUBJECT: Approval of the Award of Contract 22-528 Emergency Contract, Replacement of Ice

Casino Transformer, Playland Park, Rye, New York to West-Fair Electric Contractors Inc., P.O. Box 298, Hawthorne, New York 10532 in an amount not to exceed \$156,000.00 and authorizing the following subcontractors: D&M Electrical Contracting, Inc.; –Mace Contracting Corporation, a MBE Firm, and Open Systems

Metro NY Inc.

The attached Resolution is being submitted pursuant to the Emergency Declaration that was submitted to your Honorable Board on July 19, 2022.

The Emergency Declaration noted that during the evening of Monday, July 18, 2022, due to a lightning strike, power to the Playland Park Ice Casino along with the Tiki Bar restaurant and the Boardwalk Pier was lost. On the morning of July 19, 2022 the Department of Public Works and Transportation ("DPWT") arranged for the testing firm of Advanced Testing Systems, Inc. of Bethel, Connecticut to inspect the electrical service equipment that provides power to the Ice Casino, Tiki Bar and Boardwalk Pier and it was determined at that inspection that the transformer was damaged beyond repair.

As result of the above, an emergency situation was created due to the loss of power to the facilities noted above which included the loss of power to the mechanical system that provides air conditioning to Playland Park's main computer room.

In order to ensure proper operation of the above named facilities at Playland Park, facilitate return to the operations of these facilities, and to protect the health and safety of the public and County employees, DPWT declared an emergency situation. As an emergency, this situation cannot await competitive bidding. DPWT has arranged for an electrical contractor to undertake the work necessary to keep the facilities at Playland Park open.

As also noted in the Memorandum, the Department, following its standard emergency contract protocols, selected the firm of West-Fair Electric Contractors Inc. to perform Contract 22-528, Emergency Contract, Replacement of Ice Casino Transformer, Playland Park, Rye, New York. The emergency work for this contract includes the installation of temporary electric service to provide power to the Ice Casino, the Tiki Bar and the Boardwalk Pier. Additionally, Contract 22-528 will include the procurement and installation of a new electric service transformer.

The total cost of the work is estimated to be \$156,000.00. The Department has reviewed West-Fair Electric Contractors Inc.'s line item breakdown for the work and has determined that the costs are consistent with similar items of work on other County Projects.

West-Fair Electric Contractors Inc. will utilize the following subcontractor(s): D&M Electrical Contracting, Inc. (Transformer Installation), 90 South Central Avenue, Elmsford, New York 10523; Mace Contracting Corporation, a MBE Firm (General Construction), 35 Portman Road, New Rochelle, New York 10801; and Open Systems Metro NY Inc. (Fire Alarm System), 258 Route 117 By-Pass Road, Bedford Hills, New York 10507.
