Mr. Jenkins moved to receive and file the foregoing minutes and SEQR review, which were duly seconded and approved.

1. 108065 County Executive - Pursuant to Section 3(a)(xxi) of the Westchester County Procurement Policy and Procedures, to exempt from procurement an agreement with STEM Alliance of Larchmont-Mamaroneck.

Mr. Jenkins moved the Resolution, which was duly seconded and unanimously approved.

2. 108064 County Executive - Amend an agreement with STEM Alliance of Larchmont-Mamaroneck ("STEM") in order to extend the term of the agreement through 12/31/24, increase the not-to-exceed amount by \$375,000, bringing the total amount not to exceed payable pursuant to the agreement and First Amendment to \$1,125,000, and to revise Schedule "A" to reflect the work to be performed by STEM during the Renewal Term.
