Just 20, 2024 Honorable Members of the Board of Acquisition and Contract Michael Orth, M.S.W. Commissioner, Department of Community Mental Health Resolution to exempt from the Westchester Count of Community Pursuant to Section 3(a)(xxi) thereof to health services from National Health Section S Re: amendment to its agreement to provide certain community mental health services.

Authority is respectfully requested from your Honorable Board to exempt from the Westchester County Procurement Policy and Procedures, pursuant to Section 3(a)(xxi) thereof, the procurement of additional community mental health services (the "Additional Services"), for an amount not-to-exceed \$600,824.00, under an amendment (the "Amendment") to an agreement between the County of Westchester (the "County") and National Alliance On Mental Illness of Westchester, Inc. ("NAMP"), pursuant to which NAMI agreed to provide, pursuant to Articles 25 and 41 of the New York State Mental Hygiene Law, certain community mental health services, for the period from January 1, 2022 through December 31, 2026, for an amount not-to-exceed \$260,181.00 (the "Agreement").

Your Honorable Board previously authorized the County to enter into an agreement with each of two other entities for certain community mental health services, which are the same as, or similar to. those provided by NAMI under the Agreement. However, both of those two entities advised the County that they were unable to contract with the County. In the meantime, the County, for well over two years, has been going without the services that were anticipated to be provided by the two aforementioned entities. Since the Agreement was executed in June of 2022, NAMI has been providing such community mental health services. Accordingly, the Department of Community Mental Health concluded that NAMI could most easily and expeditiously provide the Additional Services, for the period from January 1, 2024 through December 31, 2026.

Based upon the foregoing, it is proposed that the best interests of the County would be served by exempting from the Westchester County Procurement Policy and Procedures, pursuant to Section 3(a)(xxi) thereof, the procurement of the Additional Services, under the proposed

Amendment.
