This contract includes all of the labor, materials, and equipment necessary for the rehabilitation of Runway 16/34's edge lighting, edge lighting circuit, circuit cabling, runway shoulders, runway end blast pads, signage and associated work.

The objective of this project is to ensure the runways, taxiways, and related infrastructure are in proper condition for the safe operation of aircraft and the traveling public.

This contract is in the public's best interest because it maintains a safe airfield in compliance with Federal Aviation Administration (FAA) regulations.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.
