The 2025 Capital Budget contains funds for the above referenced project.

The work under this contract consists of providing all labor, material and equipment required for the replacement of the 3 culverts and bridge including but not limited to excavation, sewer bypass and relocation, concrete work, structure placement, backfill and site work, paving and striping, and landscape restoration.

The objective of this contract is to replace structurally deficient culverts and a bridge along the Bronx River Parkway in the area of the Westchester County Center with precast concrete structures that will meet current NYSDOT and AASHTQ standards.

This contract is in the public's best interest because it will promote the health and safety of the general public by replacing structures that are highly travelled and provide a vital link to a White Plains. Further deterioration of these structures would cause serious disruptions to the public. The new structures will ensure this vital link is maintained. The new structures will also have lower maintenance requirements, therefore lowering future costs to the public.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.
