Resolution authorizing the County of Westchester to amend agreements SUBJECT:

> with various licensed consultants to provide various psychological testing and evaluations to uninsured or underinsured parents and children, as well as vulnerable adults, เกิ an aggregate amount not to exceed \$330,000, for the period from January 1, 2024 through December 31, 2024, in order to increase the not-to-exceed amount by \$25,982.75, to a

new total aggregate amount not to exceed \$355,982.75.

By resolution approved on December 21, 2023 (the "December 21st Resolution"), your Honorable Board authorized the County of Westchester (the "County") acting by and through its Department of Social Services (the "Department") to enter into agreements (the "Agreements") with the seven (7) licensed consultants listed in the December 21st Resolution as Schedule "A" (the "Consultants"), pursuant to which the Consultants would provide psychological testing and evaluations, psychiatric evaluations, sibling consults, fire setting evaluations, safety assessments, court ordered psychotherapy, functional capacity assessments to uninsured or underinsured parents and children as well as vulnerable adults upon referral from the Department's Child Protective Services, Preventive Services, Foster Care Services as well as Protective Services for Adults Programs, to be paid on a monthly basis at the individual rates set forth in the Fee Schedule attached to the December 21st Resolution as Schedule "B", not to exceed the aggregate sum of \$330,000, for the period from January 1, 2024 through December 31, 2024. The Agreements were subsequently executed.

Due to a higher-than-expected usage of the services and an increased need of Qualified Individual assessments completed by the Consultants, the Department now seeks authority of your Honorable Board to amend agreements with four (4) of the seven (7) Consultants, for the limited purpose of increasing the aggregate not-to-exceed amounts thereunder by \$25,982.75, from \$330,000, to a new total aggregate amount not to exceed \$355,982.75; to be paid retroactively in the following manner:
