The 2025 Capital Budget contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment required to rehabilitate the existing pumping station and systems, including replacement, relocation and rehabilitation of the three existing 12", 16" and 24" force mains at the Water Street Pumping Station in Peekskill, New York. The work will include, but not limited to, installation of new bar screens, pumps and pump control panel replacements, piping and valves, gas and fire detection systems, all mechanical, instrumentation and electrical systems, as well as structural and architectural repairs and replacements such as windows, lighting, driveway, sidewalks and roofs. Also the complete demo and removal of approximately 1000 LF each of the three existing 12", 16" and 24" force mains including roadway and pathway restorations. In addition, relocation and replacement of the station's emergency generator, as well as Flood Hazard Mitigation, will also be addressed.

In accordance with Chapter 635 of the Laws of Westchester County, the Department of Public Works and Transportation has evaluated the needs of this project and determined that a Project Labor Agreement (PLA) will benefit and enhance the interests of the County in the timely and efficient completion of the project. The Contractor to whom this contract is awarded will be required to execute a PLA.

The objective of this project is to rehabilitate and/or reconstruct all County owned sewage pumping stations to improve efficiency of the pumping stations and reduce energy and manpower costs. These stations suffer significant wear and tear due to constant use and require rehabilitation and replacement every 15 to 20 years.

This contract will benefit the public as it will ensure that the facility's operations are safe and environmentally compliant, thereby enhancing the health and general welfare of the residents of Westchester County.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

The Bond Underwriter or Surety must appear on the U.S. Treasury's listing of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further
