On April 16, 2025, the County of Westchester ("County") received and opened three (3) bids for Contract No. 25-503 for Runway 16/34 Shoulders and Edge Lighting Rehabilitation, Towns of Harrison and North Castle and Village of Rye Brook, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that Grace Industries LLC submitted the low bid in the amount of \$15,719,468.00.

The low bidder has been investigated and it has been found that Grace Industries LLC:

The objective of this contract is to ensure the runways, taxiways and related infrastructure are in proper condition for the safe operation of aircraft and the traveling public.

This contract is in the public's best interest because it maintains a safe airfield in compliance with Federal Aviation Administration (FAA) regulations.

The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

Payment for this contract will be made from Federal/NY State Grants and Bond Proceeds, not the County General Fund and will not impact the County tax levy.

It is my recommendation that Contract No. 25-503 be awarded to Grace Industries LLC in the amount of \$15,719,468.00.
