Re: Authority for County of Westchester, acting by and through Westchester Community College, to enter into an affiliation agreement with Sun River Health, Inc. for the provision of supervised laboratory/clinical education and instruction for Westchester Community College students

---

Westchester Community College (the "College"), through its Department of Workforce Development and Community Education, (the "Department") offers a number of programs in the healthcare field. The College offers supervised laboratory/clinical education and instruction for matriculated Westchester Community College students who are pursuing a degree or certificate in conjunction with various organizations.

Authority is hereby requested for the County of Westchester (the "County") acting by and through Westchester Community College (the "College") to enter into an affiliation agreement with Sun River Health, Inc. (the "Hospital") for supervised laboratory/clinical education for the Nursing program, (the "Program") for a term commencing on September 1, 2026, and continuing in full force and effect unless terminated earlier by either party upon written notice (the "Agreement").

There will be no cost to the College in connection with this Agreement, however, in accordance with the terms of the agreement, the College shall agree to defend, indemnify and hold harmless Hospital in a form similar to the following: The College shall defend, indemnify and hold Hospital harmless from and against any and all damages, liability, claims, costs, losses, damages or injuries to persons or property of whatever kind or nature, suits or costs, including reasonable attorney's fees, which arise out of or are directly or indirectly related to the actions or inactions of the College, its faculty, students, officers or employees, including, but not limited to, any actions brought against the other parties by any faculty or students of the College, and

any third parties.

General oversight will be provided by College staff. I believe that it is in the best interest of the College to provide clinical education and instruction programs, and I, therefore, recommend that you act favorably on the annexed proposed resolution.

Upon a communication from the President of Westchester Community College, be it hereby

**RESOLVED**, that the County of Westchester (the “County”), acting by and through Westchester Community College (the “College”), is hereby authorized to enter into an affiliation agreement with Sun River Health, Inc. (the “Hospital”) for supervised laboratory/clinical education for the Nursing program (the “Program”), for a term commencing on September 1, 2026, and continuing in full force and effect unless terminated earlier by either party upon written notice (the Agreement”); and be it further

**RESOLVED**, that there will be no cost to the College in connection with this Agreement, however, in accordance with the terms of the Agreement, the College shall agree to defend, indemnify and hold harmless Sun River Health, Inc.
