SUBJECT: Resolution authorizing a first amendment to an agreement between the

County of Westchester and Barton and Loguidice, D.P.C. for floodplain management planning in order to extend the expiration date from October

31, 2024 to April 30, 2025.

On March 11, 2024, the County of Westchester ("County") entered into a short form agreement, approved by Short Form ID number 68889, in an amount not-to-exceed \$35,000 for a term commencing retroactively on November 1, 2023 and expiring on October 31, 2024 (the "Agreement") for Toodplain management planning. The Agreement was subsequently executed.

The parties now desire to enter into a first amendment to the Agreement in order to extend the expiration date from October 31, 2024 to April 30, 2025 (the "First Amendment"). The additional time is needed in order to complete the necessary research and investigations, development of recommended strategies, report preparation and review to ensure a useful product. All of the other terms and conditions of the Agreement will remain in full force and effect.

The goal and objective of this First Amendment is to provide an analysis of the capability and feasibility for the design and implementation of a network of flood and stream gauges to function as data collection and early warning of flood events to mitigate flooding and flood damage. The Planning Department will continue to review all payment requests to make sure all of the terms of the Agreement, as amended, are met.

Authority to exempt this First Amendment from the requirements of the Westchester County Procurement Policy and Procedures pursuant to Section 3(a)xxi thereof, has been requested by your Honorable Board in accordance with a separate resolution of even date herewith.

I recommend approval of this First Amendment.
