On March 5, 2025, the County of Westchester ("County") received and opened six (6) bids for Contract No. 24-512 for Rehabilitation of Seven Bridges Road, C.R. 21 from McKesson Hill Road to NYS Route 133, A Distance of 1.21 Miles, Town of New Castle, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that Laura Li Industries LLC (WBE) submitted the low bid in the amount of \$2,044,280.00.

The low bidder has been investigated and it has been found that Laura Li Industries LLC (WBE):

- Performed satisfactory work in the past for the County.

The objective of this contract is to replace substandard areas of asphalt paving and improve roadside conditions.
