. RAYMOND SCULKY, SECRETARY On October 1, 2025, the County of Westchester ("County") received and opened seven (7) bids for Contract No. 24-501 for Drainage Improvements and Wall Reinforcement, Compost and Education Center, Grasslands Campus, Valhalla, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that ELQ Industries, Inc. submitted the low bid in the amount of \$428,500.00.

The objective of this project is to install a wastewater pumping station and low-pressure sewer (LPS) system to convey effluent from a leachate tank to an existing force main, and select demolition and reinforcement of an existing precast concrete wall at the Compost and Education Center located at the Grasslands Campus.

This Contract will benefit the public as it will ensure that the facility's operations are safe and environmentally compliant and to ensure the facility continues to serve as a demonstration site for smallscale composting in municipal, corporate, and residential yards, and provide educational information on environmental impacts, thus encouraging reductions in food waste thereby enhancing the health and general welfare of the residents of Westchester County.

The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.
