TE RESOLUTION AUTHORIZING THE COUNTY OF WESTCHESTER TO: RE:

- (1) ENTER INTO A GRANT AGREEMENT WITH THE NEW YORK STATE DIVISION OF CRIMINAL JUSTICE SERVICES TO ACCEPT \$589,026 IN GRANT FUNDS TO IMPLEMENT THE COUNTY ALTERNATIVES TO INCARCERATION SERVICE PLAN FOR THE PERIOD FROM JULY 1, 2024 TO JUNE 30, 2025; and
- (2) ENTERNATION CONTRACTS WITH THE LISTED CONTRACTORS TO IMPLEMENT THE COUNTY ALTERNATIVES TO INCARCERATION SERVICE PLAN FOR THE PERIOD FROM JULY 1, 2024 TO JUNE 30, 2025, PURSUANT TO AN APPROVED BUDGET AND IN ACCORDANCE WITH STATE APPROVAL.

Authority is sought for the County of Westchester ("County"), acting by and through its Department of Probation (the "Department") to enter into a grant agreement with the New York State Division of Criminal Justice services ("DCJS") to accept \$589,026 in grant funding to implement the Alternatives to Incarceration Service Plan (the "Plan") for the period from July 1, 2024 through June 30, 2025 ("Grant Funds").

Authority is further sought to enter into agreements with the below-listed contractors (the "Contractors") to Implement the Plan using the aforementioned Grant Funds, for the period from July 1, 2024 to June 30, 2025, pursuant to approved budgets and in accordance with State approval.

St. John's Riverside Hospital:

Direct Treatment Alternative to Incarceration-Greenburgh, Yonkers and Mount Vernon Sites \$103,118.75

Phelps Memorial Hospital Center:

Direct Treatment Alternative To Incarceration-Ossining Site

Lexington Center for Recovery

Direct Treatment Alternative to Incarceration Mount Kisco and New Rochelle

The remaining Grant Funds will be used by various County Departments as follows:

These agreements impact the County's critical priority areas in the following manners

- 1. Fiscal Responsibility The Alternative to Incarceration programs provide many services to The County. These programs are primarily funded through New York State Division of Probation and Correctional Alternatives
- 2. Safety and Security The contract with the New York State Division of Probation and Correctional Alternatives and the listed subcontractors promote public safety to County by utilizing graduated sanctions for convicted offenders and providing intensive supervision and treatment.

The proposed agreements with the Contractors are exempt from the Westchester County Procurement Policy pursuant to Section 3(a)xvii, which provides for the exception "...care, treatment, counseling...for the mentally ill...and those suffering from the disease of alcoholism or substance abuse."

It should be noted that these programs are intensely monitored by Westchester County's Criminal Justice Advisory Board. The Board meets on a quarterly basis to review and formally approve written Program Reports detailing milestones, activities and savings. Upon Board approval, these Quarterly Reports are transmitted to the State.
