Re: Authority to enter into an first amendment to increase the not-to-exceed amount of an agreement with Greenberg Traurig LLP for legislative and executive lobbying in connection with relations with the government of the State of New York, by \$25,000 to a new total aggregate amount not to exceed \$60,000 for a term from January 1, 2025 through December 31, 2025.

Authority is hereby requested for the County of Westchester ("County") to enter into an first amendment ("First Amendment") to its agreement with Greenberg Traurig LLP ("Greenberg Traurig") pursuant to which Greenberg Traurig provides lobbying in connection with its relations with the government of the State of New York, for a term from January 1, 2025 through December 31, 2025 for a total amount not to exceed \$35,000.00. The First Amendment would increase the not-to-exceed amount by \$25,000 to a new total aggregate amount not to exceed \$60,000.

By a separate Resolution, your Honorable Board approved the exemption of this proposed First Amendment from the application of the Westchester County Procurement Policy and Procedures in accordance with Section 3(a)xxi thereof.

The additional amount is required to pay the costs of additional services provided.

Accordingly, I recommend approval of the annexed Resolution.

RESOLUTION

Upon a communication from the County Executive, be it hereby:

RESOLVED, that the County of Westchester ("County") is hereby authorized to enter into a First Amendment ("First Amendment") to its agreement with Greenberg Traurig LLP ("Greenberg Traurig") pursuant to which Greenberg Traurig provides lobbying in connection with its relations with the government of the State of New York, for a term from January 1, 2025 through December 31, 2025 for a total amount not to exceed \$35,000.00 ("Agreement"). The First Amendment will increase the not-to-exceed amount by \$25,000 to a new total aggregate amount not to exceed \$60,000; and be it further

RESOLVED, that all other terms and conditions of the Agreement will remain the same; and be it further

RESOLVED, that this First Amendment is subject to County appropriations; and be it further

RESOLVED, that this First Amendment is also subject to further financial analysis of the impact of any New York State Budget (the "State Budget") proposed and adopted during the term of this Agreement. The County shall retain the right, upon the occurrence of any release by the Governor of a proposed State Budget and/or the adoption of a State Budget or any amendments thereto, and for a reasonable period of time after such release(s) or adoption(s), to conduct an analysis of the impacts of any such State Budget on County finances. After such analysis, the County shall retain the right to either terminate this Agreement or to renegotiate the amounts and rates approved herein. If the County subsequently offers to pay a reduced amount to the Contractor, then the Contractor shall have the right to terminate this Agreement upon reasonable prior written notice; and be it further

RESOLVED, that the County Executive or his authorized designee is hereby authorized to execute any documents and take any actions reasonably necessary and appropriate to effectuate the purposes of this Resolution.
