SCULKY, SECRETARY SUBJECT: Authority for the County to amend an emergency contract with Century

> Protective Services Inc. for security escort services for Department of Social Services personnel, by, (1.) modifying its scope of work by increasing the number of escorts and site locations, and changing the escort shift hours, and (2.) increasing its not-to-exceed amount by \$487,760.00, in order to pay for the additional services to be provided

under the modified scope of work.

By a resolution approved on June 6, 2024, your Honorable Board authorized the County of Westchester (the "County") to enter into an emergency contract with Century Protective Services Inc. ("Century"), pursuant to which Century was to provide the County with security escort services (the "Services") for Department of Social Services ("DSS") personnel, for a period of one (1) year, commencing upon execution, for a total amount not-to-exceed \$209,040.00, payable at a rate of \$33.50 per hour per escort (the "Agreement"; DSS3027-24). The Agreement was subsequently executed.

Under the Agreement, it specified that Century was to provide three (3) escorts. all of whom we're to be available at the single site location of 85 Court Street, White Plains, for certain shift hours.

DSS has now determined that seven (7) additional escorts are needed; that these additional escorts are needed at additional DSS locations across Westchester County; and that different shift hours may be applicable to those additional escorts.

Accordingly, authority is requested from your Honorable Board for the County to amend the Agreement by, (1.) modifying its scope of work by, (a.) increasing, by seven (7), the number of escorts to be provided, (b.) adding additional DSS locations. including, without limitation, four (4) DSS district offices, to the list of site locations where an escort will be available, and (c.) providing for different shift hours for these additional escorts; and (2.) increasing its not-to-exceed amount by \$487,760.00, from \$209,040.00 to a new total amount not-to-exceed \$696,800.00, in order to pay for the

additional services to be provided under the modified scope of work (the "Amendment"; DSS3027-A-24).

Except as specifically described above, all terms and conditions of the Agreement shall remain in full force and effect.

The proposed Amendment will serve a public purpose by ensuring that DSS personnel have additional, sufficient security in order to carry out their duties for the County and its inhabitants.

RESOLVED, that the County Executive or his duly authorized designee is hereby authorized to execute any documents and take any actions necessary and appropriate to effectuate the purposes of this resolution.
