SUBJECT: Authority to exercise the County's first one-year option under its agreement with Environmental Tech Solutions LLC, pursuant to which it was to provide housing quality standards inspections and lead-based paint inspections and risk assessments for properties that currently participate in the County's 'Emergency Housing Assistance Program', and, therefore, amend the agreement by, (1.) extending its term by one (1) year, to a new expiration date of December 31, 2026; (2.) increasing its not-to-exceed amount by \$50,500.00, in order to pay for services during the first option term; and (3.) reflecting the fact that the County will have two (2) remaining one (1) year options (DSS3043-25).

By a resolution approved on May 8, 2025, your Honorable Board authorized the County of Westchester (the "County") to enter into an agreement with Environmental Tech Solutions LLC ("ETS"), pursuant to which ETS was to provide housing quality standards inspections and lead-based paint inspections and risk assessments for properties that currently participate in the County's 'Emergency Housing Assistance Program' (the "Services"), for the period from January 1, 2025 through December 31, 2025 (the "Initial Term"), for an amount not-to-exceed \$50,500.00, payable on a unit-cost basis pursuant to an approved budget, with the County having the option, in its sole discretion, to extend the term for up to three (3) additional one (1) year periods (each an "Option Term"), on the same terms as the Initial Term, except for the unit costs for the Services, and that each Option Term shall have a not-to-exceed amount of \$50,500.00 (the "Agreement"; DSS3043-25). The Agreement was subsequently executed.

The County continues to require the Services. Therefore, the Department of Social Services ("DSS") reviewed and analyzed the unit cost for the first Option Term under the Agreement and determined that it is reasonable.

Therefore, the County respectfully requests authority from your Honorable Board to exercise the County's first one-year option, and, therefore, amend the Agreement by, (1.) extending its term by one (1) year, to a new expiration date of December 31, 2026; (2.) increasing its not-to-exceed amount by \$50,500.00, in order to pay for the Services during the first Option Term; and (c) reflecting the fact that the County will have two (2) remaining one (1) year options (DSS3043-A-25; the "First Amendment").

Except as specifically described above, all terms and conditions of the Agreement shall remain in full force and effect.

The proposed First Amendment will serve a public purpose by providing the County, for an additional year, with certain services that are needed in order to help evaluate the suitability of premises for continued use in the County's 'Emergency Housing Assistance Program'.

The goal and objective of the proposed First Amendment will be tracked and monitored by the staff of DSS.

RESOLUTION

Upon a communication from the Commissioner of Social Services, be it hereby:

RESOLVED, that the County of Westchester (the "County") is hereby authorized to exercise the County's first one-year option under an agreement with Environmental Tech Solutions LLC ("ETS"), pursuant to which ETS was to provide housing quality standards inspections and lead-based paint inspections and risk assessments for properties that currently participate in the County's 'Emergency Housing Assistance Program' (the "Services"), for the period from January 1, 2025 through December 31, 2025, for an amount not-to-exceed \$50,500.00, payable on a unit-cost basis pursuant to an approved budget, with the County having the option, in its sole discretion, to extend the term for up to three (3) additional one (1) year periods (each an "Option Term"), on the same terms as the initial term, except for the unit costs for the Services, and that each Option Term shall have a not-to-exceed amount of \$50,500.00, (DSS3043-A-25 the "Agreement") and, therefore, amend the Agreement by, (1.) extending its term by one (1) year, to a new expiration date of December 31, 2026; (2.) increasing its not-to-exceed amount by \$50,500.00, in order to pay for the Services during the first Option Term; and (c) reflecting the fact that the County will have two (2) remaining one (1) year options; and be it further

RESOLVED, that except as specifically hereby authorized to be amended, all terms and conditions of the Agreement shall remain in full force and effect; and be it further

RESOLVED, that the County Executive or his duly authorized designee is hereby authorized to execute any documents and take any actions necessary and appropriate to effectuate the purposes of this resolution.
