RE:	Authority for the County of Westchester to enter into a Grant Agreement with the Federal Transit Administration ("FTA") to accept \$12,431,250.00 in Federal Transit Capital Assistance (Grant Agreement NY-2025-017).

Authority is requested for the County of Westchester (the "County") to enter into an agreement with the Federal Transit Administration ("FTA") to accept **\$12,431,250** in Federal Transit Capital Assistance. A 20% County match is required to receive the FTA funds bringing the total funding amount to **\$14,625,000**. The funding sources are broken down as follows:

Funds received from this grant will be utilized as follows:

5339 Low-No Funds - Purchase 40' Replacement Buses (\$12,431,250.00 Federal)

Westchester County is requesting federal assistance in the amount of \$12,431,250.00, 5339 Low-No funds. The total project cost is \$14,625,000.09, with the County providing a 15% local match of \$2,193,750.00. The 5339 Low-No funds in this grant will go toward the procurement of up to 15 Hybrid Diesel-Electric and/or all electric 40-foot replacement buses, related equipment, vehicle repair spare parts, vehicle inspection tools and vehicle specification review. The current 2008 buses have a useful life of 12 years and 500,000 miles and were eligible for replacement in 2021. The new buses will also have a useful life of 12 years and 500,000 miles. The list of buses being replaced with the required information is attached to the grant.

The receipt of federal funds will be monitored by both the Department of Public Works and Transportation and the Department of Finance.

Upon a communication from the Commissioner of Public Works and Transportation, be it hereby:

RESOLVED, that the County Executive or his authorized designee is authorized to file any other document required by the U. S. Department of Transportation effectuating the purpose of Title VI of the Civil Rights Act of 1964 and to set forth and execute affirmative minority business policies in connection with the project; and be it further

RESOLVED, that the County Executive or his duly authorized designee be and hereby is authorized to execute any and all documents necessary and appropriate to effectuate the purposes hereof.
