Jenkins Westchester County Executive Robin Schlaff Director, Office for Women June 27, 2025 Authority to enter into a grant agreement with the Market Children and Family State Authority to enter into a grant agreement with the New York State Office of Subject: Children and Family Services to accept a grant for a total amount not to exceed \$331,895, with matching funds of 20%, to enable the County to provide non-residential support services for victims of domestic violence, for a five (5) year period commencing on April 1, 2025 and continuing through March 31, 2030.

The County of Westchester, acting by and through its Office for Women, (the "County") is requesting authority to entermito a grant agreement with the New York State Office of Children and Family Services ("OCFS") to accept a grant awarded to it by OCFS, for a total amount not to exceed \$331,895, to enable the County to provide non-residential support services for victims of domestic violence, for a five (5) year period commencing on April 1, 2025 and continuing through March 31, 2030 (the "Grant Agreement"). The funding amount per year shall not exceed \$66,379. Pursuant to the terms of the Grant Agreement, the County will be required to contribute 20% in non-federal matching funds, in an amount not to exceed \$13,275.80 per year.

The Grant Agreement will serve a public purpose by making available to the County certain Federal pass-through funds that the County can and will use to provide nonresidential support services for victims of domestic violence for a five (5) year period. It s funded by federal Family Violence Prevention and Services Act ("FVPSA") funds.

The goal and objective of the Grant Agreement is in the best interests of the County in terms of the public health, safety and general welfare, as this assistance will enable victims to become safe and independent and to avoid returning to their abusers or becoming dependent on public assistance.

The goal and objective of the Grant Agreement is also in the best interests of the County in terms of fiscal responsibility, as it will make available to the County certain Federal pass-through funds for the aforementioned work.

The Grant Agreement will be tracked and monitored by the Office for Women.

**RESOLVED**, that the County of Westchester, acting by and through its Office for Women, (the "County") is hereby authorized to enter into a grant agreement (the "Grant Agreement") with the New York State Office of Children and Family Services ("OCFS") pursuant to which the County will accept a grant awarded to it by OCFS to provide nonresidential support services for victims of domestic violence, for a five (5) year term from April 1, 2025 through March 31, 2030, for a total amount not to exceed \$331,895, consisting of federal Family Violence Prevention and Services Act funds; and be it further

**RESOLVED**, that the funding amount per year will not exceed \$66,379; and be it further

**RESOLVED**, that pursuant to the terms of the Grant Agreement, the County will be required to contribute 20% in non-federal matching funds, in an amount not to exceed \$13,275.80 per year; and be it further

**RESOLVED**, that the County Executive or his duly authorized designee be and hereby is authorized and empowered to execute any and all documents and take any actions necessary to effectuate the purposes hereof.
