RE:	Authority for the County of Westchester to enter into a Grant Agreement with the Federal Transit Administration (FTA) for \$1,464,000 in Federal Transit Capital Assistance (Grant Agreement NY-2024-068-00)

Authority is requested for the County of Westchester (the "County") to enter into an agreement with the Federal Transit Administration ("FTA") for \$1,464,000 in Federal Transit Assistance. The County's match, \$3,111,000, is required to receive the FTA funds for a total of \$4,575,000. The funding sources are broken down as follows:

Funds received from this grant will be utilized as follows:

Capital Cost of Contracting (\$1,464,000 Federal)

These funds will be applied to the capital cost of contracting to fund the operation of bus service in Westchester and Putnam Counties for the service period of 1/1/2022 - 12/31/2022. The goal of this project is to provide funding for the operation of bus service on Bus Route 77 and for shuttle services to and from train stations and corporate parks within the Bee-Line System. If these grant funds are not accepted for the aforementioned project, Bee-Line transit service will be negatively impacted.

The receipt of reimbursement funds will be monitored by both the Department of Public Works and Transportation and the Department of Finance.
