RE: Resolution authorizing the County of Westchester to enter into an agreement

with AllPaid, Inc. pursuant to which AllPaid, Inc. will offer its remote pay system to those individuals who wish to pay, via debit or credit card, fines or fees issued by the Westchester County Taxi & Limousine Commission, or prearraignment bail for criminal arrests set by any local court, or payments of civil judgments entered by any local court, as well as payments for law enforcement personnel attending classes at the Police Academy, for a term of

five (5) years commencing retroactive to April 1, 2024 and continuing

through March 31, 2029.

Attached for your consideration is a Resolution, which, if approved, will authorize the County of Westchester (the "County"), acting by and through its Department of Public Safety ("WCDPS"), to enter into an agreement (the "Agreement") with AllPaid, Inc. ("AllPaid"), pursuant to which AllPaid will offer its remote pay system to those individuals who wish to pay, via debit or credit card, fines or fees issued by the Westchester County Taxi & Limousine Commission ("WCTLC"), or pre-arraignment bail for criminal arrests set by any local court for the benefit of WCDPS, or payments of civil judgments entered by any local court for the benefit of WCDPS, as well as payments for law enforcement personnel attending classes at the Police Academy.

The proposed Agreement will be for a five (5) year term commencing retroactive to April 1, 2024 and continuing through March 31, 2029. The credit card or debit card holder will be responsible to pay for all fees concerning the transactions directly to AllPaid. There will be no cost to the County in connection with this agreement. The County will have the right to terminate the agreement on ten (10) days notice if it is determined to be in its best interest.

This Agreement will provide an additional method of payment for those individuals who are required to pay fines or fees issued by the WCTLC, or pre-arraignment bail or civil judgments. In addition, the Agreement will allow for payments by law enforcement personnel attending classes at the Police Academy.

This Agreement is in the best interest of the County as it will promote the fiscal health of the County. Historically, payments were limited to cash only and as such, a number of individuals required to pay fines or fees failed to do so. By offering an additional method of payment, this Agreement will provide the County with a better assurance of payment.

The performance of this Agreement will be tracked and monitored by the WCTLC and by the WCDPS. Both WCTLC and WCDPS shall evaluate the success of this program by analyzing a year-end report that will record the number of credit card transactions and the amount of fines collected as compared to other types of transactions.

The Agreement is exempt from the Westchester County Procurement Policy pursuant to Section 3(b) thereof.

## RESOLUTION

Upon a communication from the Commissioner-Sheriff of Public Safety, be it hereby

**RESOLVED**, that the County of Westchester ("County"), acting by and through its Department of Public Safety ("WCDPS"), is authorized to enter into an agreement (the "Agreement") with AllPaid, Inc. ("AllPaid"), pursuant to which AllPaid will offer its remote pay system to those individuals who wish to pay, via debit or credit card, fines or fees issued by the Westchester County Taxi & Limousine Commission, or pre-arraignment bail for criminal arrests set by any local court for the benefit of WCDPS, or payments of civil judgments entered by any local court for the benefit of WCDPS, as well as payments for law enforcement personnel attending classes at the Police Academy; and be it further

**RESOLVED**, that the Agreement will be for a five (5) year term commencing retroactive to April 1, 2024 and continuing through March 31, 2029. The County shall have the right to terminate the Agreement on ten (10) days notice if it is determined to be in its best interest; and be it further

**RESOLVED**, that the credit card or debit card holder will be solely responsible to pay for all fees concerning the transactions directly to AllPaid. There will be no cost to the County in connection with this Agreement; and be it further

**RESOLVED**, that the County Executive or his authorized designee is authorized and empowered to execute and deliver all instruments and take all actions necessary or appropriate to effectuate the purposes hereof.
