On October 29, 2025, the County of Westchester ("County") received and opened thirteen (13) bids for Contract No. 24-531 Boardwalk Replacement and Trail Rehabilitation, Briarcliff-Peekskill Trailway, Town of Cortlandt, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that Papitto Construction Co., Inc. (WBE) submitted the low bid in the amount of \$1,101,075.00.
