On April 9, 2025, the County of Westchester ("County") received and opened seven (7) bids for Contract No. 24-500 Biological Nitrogen Removal Media Replacement and Aeration Tank Rehabilitation, Mamaroneck Water Resource Recovery Facility, Mamaroneck, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that ELQ Industries, Inc. submitted the low bid in the amount of \$40,467,409.43. ELQ Industries, Inc. has proposed the use of the following subcontractor: Filingeri Electrical Contracting Corp. (Electrical), 3510 Lexington Avenue, Monhegan Lake, New York 10547.

The low bidder has been investigated and it has been found that ELQ Industries, Inc.:

This work is necessary because the BNR IFAS media has experienced irreparable damage and needs to be replaced. The damage is jeopardizing the Department's ability to meet the EPA mandated nitrogen removal requirements. The mixers have reached the end of their useful life and more efficient mixers are available. The Department is required to keep its water and wastewater treatment equipment in a state of good repair in accordance with State and Federal regulations.

The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 24-500 be awarded to ELQ Industries, Inc. in the amount of \$40,467,409.43.
