On October 16, 2024, the County of Westchester ("County") received and opened six (6) bids for Contract No. 22-526 Rehabilitation of Weaver Street Pumping Station, Mamaroneck Valley Sanitary Sewer District, Town of Mamaroneck, New York.

The bids were reviewed by the Departmen of Public Works and Transportation ("Department") and it was determined that ECCO III Enterprises, Inc. submitted the low bid in the amount of \$6,808,000.00. ECCO III Enterprises, Inc. has proposed the use of the following subcontractors: Filingeri Electrical Contracting Corp. (Electrical), 3510 Lexington Avenue, Mohegan Lake, New York 10547; Joe Lombardo Plumbing & Heating of Rockland Inc. (Plumbing), 321 Spook Rock Road, Suite 109A, Suffern, New York 10901; and Vamco Sheet Metal, Inc. (HVAC), 3090 Route 9, Cold Spring, New York 10516.

The low bidder has been investigated and it has been found that ECCO III Enterprises, Inc.:

The objective of this contract is to prevent failure including the occurrence of sewage overflow emergencies that could allow sewage onto the surrounding properties and cause violations of the pumping station's State Pollutant Discharge Elimination System ("SPDES") Permit.

This contract is in the public's best interest because it effectuates long-term rehabilitation of these critical sewer system collection components avoiding potential adverse environmental impact to the surrounding properties.

The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 22-526 be awarded to ECCO III Enterprises, Inc. in the amount of \$6,808,000.00.
