The 2025 Capital Budget contains funds for the above referenced project.

The work under this contract includes all labor and materials necessary to furnish and install a new uninterruptible power system at the Public Safety Headquarters. Work includes the complete installation and interconnections of electrical systems and associated work.

The objective of this contract is to replace the current uninterruptible power system at the Public Safety Headquarters in Hawthorne, New York.

This contract is in the public's best interest because it will ensure an uninterrupted power supply to the Public Safety Headquarters in the event of a power outage.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

RESOLVED, that the Commissioner of Public Works and Transportation be and hereby is authorized to solicit bids by public advertisement on the following contract:

and be it further

RESOLVED, that adequate and sufficient security for the faithful performance of this contract shall be deemed to be receipt of a performance and payment bond in an amount equal to 100% of the total contract amount, and in a form approved by the County Attorney. The Bond Underwriter or Surety must appear on the U.S. Treasury's listing of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further

RESOLVED, that this advertisement for bids will state that pursuant to Chapter 308 of the Laws of the County of Westchester, the policy of the County is to encourage the meaningful and significant participation on County contracts for business enterprises owned by persons of color and women - Minority Business Enterprise (MBE) and Women Business Enterprise (WBE); and be it further
