SUBJECT: Authority for the County of Westchester to enter into an agreement with

Grand Canyon University, pursuant to which Department of Social

Services employees enrolled in Grand Canyon's social work program will

participate in a field education/internship placement at the County's Department of Social Services, delivering quality care to the Department's

clients, for a period commencing retroactively on May 14, 2025 and

continuing through May 1, 2030.

Authority is respectfully requested from your Honorable Board for the County of

Westchester (the "County"), acting by and through its Department of Social Services (the "Department"), to enter into an agreement ("the proposed Agreement," DSS2002PD-25) with Grand Canyon University ("Grand Canyon"), pursuant to which Department employees enrolled in Grand Canyon's social work program (the "Students") will participate in a field education/internship placement at the Department, delivering quality care to the Department's clients, for a period commencing retroactively on May 14, 2025 and continuing through May 1, 2030. There will be no monetary compensation paid to the County for its participation in this program.

Pursuant to the proposed Agreement, Grand Canyon and the Department will work in collaboration to develop a field education/internship program and continue to deliver quality care to the Department's clients. Grand Canyon, in coordination with the Department, will provide the Students with an adequately supervised program of field education in social work. The field practicum experience will develop Students' social work skills in real-world organizational and community environments, and will provide the Students with the academic credits necessary to earn a degree in social work from Grand Canyon.

The goals and objectives of the proposed Agreement are to provide the fieldwork and clinical experience necessary to educate Grand Canyon's social work students in a professional environment.

The goals and objectives of the proposed Agreement are in the best interests of the County in terms of public health because the field education/internship program will train future social workers whose services are needed to ensure that children and residents in the County are receiving proper assistance and social services.

The goals and objectives of the proposed Agreement will be tracked and monitored by the Department.

Pursuant to the proposed Agreement, the County will not be engaging in the procurement of goods and services; accordingly, the County's Procurement Policy and Procedures does not apply.
