The 2025 Capital Budget contains funds for the above referenced project.

The work under this contract consists of all labor, material, and equipment required for the rehabilitation of the two (2) bridges including but not limited to excavation, concrete work, structure placement, masonry and stone work, backfill and site work, paving and striping, and landscape restoration and associated work.

The objective of this contract is to renabilitate structurally deficient bridges over the Bronx River and Bronx River Parkway in the area of the Village of Scarsdale in connection to Ardsley Road in the Town of Greenburgh which is one of the main arterial roads connecting surrounding towns to the west area of Westchester County at Hudson River, to meet current NYSDOT and AASHTO standards.

This contract is in the public's best interest because the structures are highly travelled and provide a vital link to White Plains. Further deterioration of these structures would cause serious disruptions to the public. The rehabilitated structures will ensure this vital link is maintained. The rehabilitated structures will also have lower maintenance requirements, therefore lowering future costs to the public.

The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

RESOLVED, that adequate and sufficient security for the faithful performance of this contract shall be deemed to be receipt of a performance and payment bond in an amount equal to 100% of the total contract amount, and in a form approved by the County Attorney. The Bond Underwriter or Surety must appear on the U.S. Treasury's listing of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further

RESOLVED, that this advertisement for bids will state that pursuant to Chapter 308 of the Laws of the County of Westchester, the policy of the County is to encourage the meaningful and significant participation on County contracts for business enterprises owned by persons of color and women - Minority Business Enterprise (MBE) and Women Business Enterprise (WBE); and be it further
