Repairs, Norwood F. solicit bids by public advertisement for Contract No. 25-296 Coating Installation and Repairs, Norwood E. Jackson Correctional Center, in order to revise the security for the faithful performance of the contract from a performance and payment bond to a retainage

of 5% of all work completed on an annual basis.

By resolution approved on July 3, 2025 (the "July 3rd Resolution"), your Honorable Board authorized the County of Westchester, acting by and through the Department of Public Works and Transportation (the "Department"), to solicit bids by public advertisement for Contract No. 25-206, Coating Installation and Repairs, Norwood E. Jackson Correctional Center, Department of Public Works and Transportation, Westchester County, New York (the "Contract"). The July 3<sup>rd</sup> Resolution specified that adequate and sufficient security for the faithful performance of the Contract was deemed to be the furnishing of a performance and payment bond.

The Department now seeks to change the performance security requirement for this Contract from a performance and payment bong to a retainage of 5% of all work completed on an annual basis. Accordingly, authority is now respectfully requested to amend the July 3<sup>rd</sup> Resolution for the limited purpose of changing the performance security requirement from a performance and payment bond, to a retainage of 5% of all work completed on an annual basis. It should be noted that under the retainage performance security method, the contractor may request payment of said retainage upon each annual anniversary subject to the successful completion of all work performed during that period.

Except as specifically amended hereby, all other terms and conditions set forth in the July 3<sup>rd</sup> Resolution shall remain the same.

The proposed form of Resolution to accomplish the foregoing is attached hereto.

Upon communication from the Commissioner of Public Works and Transportation, be it hereby

**RESOLVED**, that the resolution approved on July 3, 2025 (the "July 3rd Resolution") which authorized the County of Westchester to solicit bids by public advertisement for Contract 25-206 for Coating Installation and Repairs, Norwood E. Jackson Correctional Center, Department of Public Works and Transportation, Westchester County, New York, is hereby amended by changing the performance security requirement from a performance and payment bond, to a retainage of 5% of all work completed on an annual basis. Under the retainage performance security method, the contractor may request payment of said retainage upon each annual anniversary subject to the successful completion of all work performed during that period; and be it further

**RESOLVED**, that except as specifically amended hereby, all remaining terms and conditions set forth in the July 3<sup>rd</sup> Resolution shall remain unchanged; and be it further
