On December 10, 2025, the County of Westchester ("County") received and opened five (5) bids for Contract No. 23-512 for Resurfacing and Additional Improvements of Central Park Avenue, C.R. #47-I/II/IIA/IV, From Bronx/Westchester County Line to New York State Thruway Bridge and Rehabilitation of Access Ramps to and from Palmer Road, A Total Distance of 5.95 Miles, City of Yonkers, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that ELQ Industries, Inc. submitted the low bid in the amount of \$14,255,942.00.
