SUBJECT: Authority to enter into an agreement with the Metropolitan Transportation Authority

regarding the County's use of its 'OMNY' fare payment system for the Bee-Line Bus System, for an initial term of five (5) years, on specified payment terms and other terms.

(Agreement No. DOTOP12-25)

Authority is requested for the County of Westchester (the "County") to enter into an agreement (the "Agreement") with the Metropolitan Transportation Authority (the "MTA"), pursuant to which the MTA will allow the County to use the MTA's 'OMNY' fare payment system for the County's Bee-Line Bus System (the "Bee-Line"), for an initial term of five (5) years, commencing on the "Effective Date" (as defined in the Agreement), with the term automatically renewing under the same terms and conditions (except as otherwise specified in the Agreement) for additional one (1) year periods thereafter, unless the County or the MTA, at least ninety (90) days prior to the expiration of the then-current term, notifies the other party of its intent not to renew the Agreement, with said Agreement requiring the County's payment of the fees specified below, and said Agreement otherwise being on the terms contained in Exhibit 1, which is attached hereto:

The proposed Agreement will serve a public purpose by allowing the County to continue using an MTA payment system, through OMNY, after the retirement of the MetroCard, for the collection of fares on its Bee-Line bus routes, and to receive from the MTA certain ancillary services in support of the County's fare collection with OMNY.

The goal and objective of the proposed Agreement is in the best interests of the County in terms of fiscal responsibility, as the County's use of the OMNY system, and the County's receipt of ancillary services in support of that system, is a cost-efficient way for the County to collect fares on the County's Bee-Line bus routes.

The goals and objectives of the proposed Agreement will be tracked and monitored by the staff of the Department of Public Works and Transportation.

## RESOLUTION

Upon a communication from the Commissioner of Public Works and Transportation, be it hereby:
