SUBJECT: Authority for the County of Westchester to amend license agreement IT-1720 with

the State of New York, acting by and through the New York State Police (NYSP"), pursuant to which the County granted the NYSP a license to install, maintain and operate its radio equipment at the property owned by the County known as Mountain Lakes Park in the Town of North Salem, in order to permit NYSP to

modify its radio equipment.

Authorization is sought from your Honorable Board to amend license agreement IT-1720, dated October 25, 2022, (the "Agreement") between the County of Westchester (the "County") and the State of New York, acting by and through the New York State Police ("NYSP"), pursuant to which the County granted the NYSP a license to install antennas and related equipment onto the County Tower and into the County Shelter at the property owned by the County known as the Mountain Lakes Park in the Town of North Salem, NY ("Site") for the installation, operation and maintenance of radio equipment and appurtenant equipment in connection with such use, for a term commencing on October 25, 2022 and terminating five (5) years thereafter with the Licensee having the sole option to renew the Agreement for an additional five (5) year term upon prior written notice to the County.

The NYSP now wishes to modify its radio equipment at the Site by adding a low profile cellular subscriber antenna on to the County's transmission line support ice bridge and adding associated equipment in the County Shelter. The County is amenable to this modification.

The proposed amendment will serve a public purpose by promoting the safe and effective operation of first responder radio systems within the County. County staff monitors the operation of the equipment on a regular basis.

Except as otherwise expressly provided herein, all other terms and provisions set forth in the Agreement shall remain in full force and effect.

Approval of the attached resolution by your Honorable Board is requested.
