SUBJECT: Authority to enter into a Terminal Use Agreement with Qualified Arlines operating, or

seeking to operate, at the Westchester County Airport, for the term from June 1, 2025

through May 31, 2030 (WCA 25007).

Authority of your Honorable Board is requested for the County of Westchester ("County") to enter into a Terminal Use Agreement ("TUA") with Qualified Airlines operating, or seeking to operate, at the Westchester County Airport ("Airport") for a term from June 1, 2025 through May 31, 2030.

The TUA will include: (1) a requirement that each Qualified Airline abides by the provisions of the Terminal Use Regulations codified in Section 712.462 of the Laws of Westchester County; (2) a requirement that each Qualified Airline abides by the Technical Specifications and Procedural Requirements imposed by the Airport Manager and Director of Aviation; (3) a list of the permitted uses of space and services within the Airport Terminal by Qualified Airlines and the applicable fees, rates and charges; and (4) a description of the ground handling services provided by the County and the applicable fees.

The new TUA will provide a comprehensive mechanism to allocate limited Terminal space at the Airport, to assess fees for the use of such space and for County services, to set forth the relative rights and responsibilities of the parties involved in commercial aviation at the Airport, and, thereby, to preserve the long-standing policies associated with allocation of limited commercial airline capacity at the Airport. This new agreement is consistent with and complements the provisions of Section 712.462 of the Laws of Westchester County.

The goal of this action is to ensure that the County is able to maintain control over the use of the Airport facilities, including the aircraft ramp and Terminal, for the next five years.

I recommend approval of the annexed Resolution.
