SUBJECT: Resolution authorizing the County of Westchester to enter into a

License Agreement with the Town of Mount Pleasant to use certain

County-owned vacant land in the Town of Mount Pleasant, identified as a portion of Section 106.18, Block 1 and Lot 2 on the Tax Maps for the Town of Mount Pleasant, for the operation of a commuter parking lot for the period commencing retroactively on May 1, 2024 continuing through December 31, 2025 at a license fee of \$2,690.00

per month (Agreement No. 25-925).

Authority is requested for the County of Westchester (the "County") to enter into a License Agreement with the Town of Mount Pleasant (hereinafter the "Licensee"), for the use of certain County-owned vacant land in the Town of Mount Pleasant, identified as a portion of Section 106.18, Block 1 and Lot 2 on the Tax Maps for the Town of Mount Pleasant (the "Licensed Premises") for a term commencing retroactively on May 1, 2024 and continuing through December 31, 2025, unless sooner terminated

The Licensed Premises are to used and operated by the Licensee solely and exclusively for commuter parking lot for the Hawthorne Train Station

In consideration for the privilege of operating the parking lot, the Licensee will pay the County a license fee of \$2,690.00 per month.

The public purpose of this agreement is that it encourages the public to use mass transportation which benefits the environment. The ultimate goal of the agreement is to provide revenue to the County. This agreement allows more commuters to use mass transit rather than using personal vehicles which benefits the County by reducing air pollution and traffic in addition to providing revenue to the County.

The program will be tracked and monitored by site inspections.

This agreement is exempt from the Westchester County procurement policy pursuant to Section 3 (b), thereof.

Accordingly, your favorable action on the annexed Resolution is most respectfully urged and recommended.
