**SUBJECT:** Resolution for Authority to Advertise Contract No. 25-206 **Coating Installation and Repairs** Norwood E. Jackson Correctional Center Grasslands Campus, Valhalla, New York

The 2025 Operating Budget contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment required to install coatings for renovations, waterproofing and repairs at the Norwood E. Jackson Correctional Center, Grasslands Campus, Valhalla, New York. This contract is for a term of three (3) years with one two (2) year renewal at the discretion of the County.

The objective of this contract is to provide necessary services to address waterproofing.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring the structural integrity and weather tightness of the Norwood E. Jackson Correctional Center and thus reducing maintenance costs.

As expenditures are made pursuant to this authorization, detailed records will be kept in the County's online financial system. These records will be easily accessible by Finance, Budget and department staff and will be reviewed regularly to ensure that funds are used appropriately.

RESOLVED, that the Commissioner of Public Works and Transportation be and hereby is authorized to solicit bids by public advertisement on the following contract:

CULK SECRETARY **RESOLVED**, that adequate and sufficient security for the faithful performance of this contract shall be deemed to be furnishing of a performance and payment bond in an amount equal to the first year's contract amount, in a form approved by the County Attorney. In substitution thereof, an annual, renewable performance and payment bond may be furnished, in an amount equal to that year's contract amount in a form approved by the County Attorney, so long as an annual bond remains in place, uninterrupted, for the duration of the contract. The Bond Underwriter or Surety must appear on the U.S. Treasury's listing of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further

**RESOLVED**, that this advertisement for bids will state that pursuant to Chapter 308 of the Laws of the County of Westchester, the policy of the County is to encourage the meaningful and significant participation on County contracts for business enterprises owned by persons of color and women -Minority Business Enterprise (MBE) and Women Business Enterprise (WBE); and be it further
