SCULKY, SECRETARY Authority for the County of Westchester, acting by and through Re: Westchester Community College, (the "College") o enter into an agreement with The Bristal Assisted Living at Armonk (the "Company") to provide educational programs to residents of the Company, for a term commencing on or about June 1, 2025, for 6 weeks sessions from 2:00 -3:30 PM, and ending on or about July 7, 2025, where the Company shall

pay the College Two Thousand Dollars (\$2,000.00).

Authority is hereby requested to authorize the County of Westchester (the "County"), acting by and through Westchester Community College (the "College"), to enter into an agreement with The Bristal Assisted Living at Armonk (the "Company") to provide educational programs (enrichment courses) to its residents at the Company's premises, for a term commencing on or about June 1, 2025, for 6 weeks sessions from 2:00 – 3:30 PM, and ending on or about July 7, 2025, where the Company shall pay the College flat fee Two Thousand Dollars (\$2,000.00) which includes the course' instruction and materials. Such a sum shall be due and payable by check on or before June 1, 2025

The Company will identify approximately twenty (20) of its residents to participate in the program. The program will be conducted by instructors identified by the College.

This agreement is in the County's best interest in that the scope of this Program is to support the College's mission of lifelong learning and provide personal enrichment and life-long learning classes to seniors in the community.

Pursuant to the terms of the proposed agreement, College will provide the following indemnification: agree to defend, indemnify and hold harmless the Company and Affiliates and its landlords and master landlords (hereinafter Landlords), if any, and each of its respective officers, agents, employees, subsidiaries, affiliates, stockholders and assigns from and against any and all suits, claims, liabilities, losses, injuries to persons or damages to property, costs or expenses of any kind (including reasonable

attorneys' fees and disbursements) caused by or resulting from the acts or omissions, negligence and willful misconduct of the College, its agents, or employees.

RESOLVED, that the County Executive or his duly authorized designee be and hereby is authorized and empowered to execute any and all instruments and to take all action necessary to implement the purposes hereof.
