The work under this contract will consist of all necessary labor, materials and equipment to provide Security Escorts to accompany DSS Child Welfare staff, including Child Protective, Reventive Service and Foster Care, out of the office to make contact with DSS customers in the community, as needed.

Performance security in the form of cash, certified check, irrevocable letter of credit, of performance and payment bond in the amount of 30% of the total annual contract will be required.
