The 2025 Capital Budget contains funds for the above referenced project.

This contract includes all of the labor, materials, and equipment necessary for the resurfacing and related improvements of Playland Parkway, including repairs of drainage structures, new curbing, guiderail replacement, traffic signal improvements, and new pavement markings and associated work. The contract also includes the reconstruction of the Boston Post Road Bridge including the replacement of existing wearing surface, stone masonry, repointing, and pavement markings and associated work.

The objective of this project is to replace substandard asphalt paving, improve roadside conditions, and strengthen the existing bridge structure.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring Playland Parkway and Boston Post Road Bridge meet current codes and standards as well as reducing the County's annual maintenance costs. The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.
