RE: Authorization for the County of Westchester to amend license agreement IT-1607, dated August 14, 2020, with the Town of Bedford, pursuant to which the County, among other things, granted to the Town (and its sublicensees) a license to operate their public safety radio equipment and antennas on the County tower and in the County shelter located at 75 Guard Hill Road, in order to modify the Town's radio equipment and antennas at the site.

The County of Westchester (the "County") and the Town of Bedford (the "Town") entered into license agreement IT 1607, dated August 14, 2020, (the "Agreement"), pursuant to which the County, among other things, granted to the Town (and its sublicensees) a license to operate their public safety radio equipment and antennas on the County tower and in the County shelter located on the Town-owned real property at 75 Guard Hill Road in the Town (the "Site").

Authorization is being sought to amend the Agreement to authorize the Town to modify its radio equipment and antennas at the Site, namely to modify its radio equipment in the County shelter and install a GPS antenna on the County's transmission-line support (cable ice bridge) between the County shelter and County tower.

Except as otherwise expressly provided herein, all other terms and provisions of the Agreement shall remain in full force and effect.

The proposed amendment will serve a public purpose by promoting the safe and effective operation of first responder radio systems within the County. County staff monitors the operation of the equipment on a regular basis.

Accordingly, approval of the attached resolution by your Honorable Board is most respectfully requested.
