MOND SCULKY, SECRETARY Request for Authorization to Settle the lawsuit of M.R., an infant, by her mother Re:

and natural guardian, Rita Rabadi against County of Westchester, City of Rye, Standard Amusements LLC, United Parks Holdings LLC, Dragon Partners, LLC and Rye Playland a/k/a Playland Amusement Park in the amount of \$135,000.00.

Attached for your consideration is a resolution which, if approved by your Honorable Board, would authorize settlement of the tawsuit, M.R., an infant, by her mother and natural guardian, Rita Rabadi, against the County of Westchester, City of Rye, Standard Amusements LLC, United Parks Holdings LLC, Dragon Partners, LLC and Rye Playland a/k/a Playland Amusement Park in the amount of \$135,000.00, inclusive of attorney's fees.

Rita Rabadi, mother and natural guardian of infant M.R, brought this personal injury action against the County alleging that the County was negligent in its operation of the Kiddy Boat ride at Rye Playland Amusement Park on August 25, 2021, in that her infant daughter was caused to slip and fall on an unsecured box present on the outside floor of the ride. The incident occurred as she exited the ride upon the direction of the ride attendant. The facts establish that after she slid down the unsecured box at the base of the ride at about 3:00 p.m., she fell on the box, and then the infant was subsequently caused to straddle the box and land on the floor, primarily injuring her vaginal area. The infant was five years old at the time of the incident. After receiving some minor treatment at the park's first aid station, the infant child was taken by ambulance to White Plains Hospital, whereupon she underwent surgery to the vaginal area in order to repair and suture a vaginal laceration sustained as a result of her fall. As a result of the incident, plaintiff alleges that her daughter sustained trauma to her vaginal area, including multiple lacerations, vaginal scarring, an overnight hospital stay, sensitivity, shock, difficulty walking, emotional injuries involving the development of her vaginal area and alleged future potential for sexual dysfunction. As a result of the incident, plaintiff alleges that the County allowed the Kiddyland Boat Ride to be dangerous, unstable, unsecured, allowing a trap/hazard to exist, and in failed to take precautions to avoid the incident which was foreseeable.

At the time of the incident, the box that was underneath the ride, was unsecured to the floor and as the infant plaintiff exited the ride upon the ride attendant's direction, the box moved upon the floor, and the infant slid across the floor injuring her vaginal area, while straddling the box. In light of the facts, the infant's age, and the significant fact that the box was unsecured, coupled with the ride attendant's directing the plaintiff to exit the ride, the County determined that it was prudent to settle this matter prior to trial, as it is definitely likely that the County will be found negligent and liable for the infant's injuries. The plaintiff's expert opined that the injuries that the infant sustained were permanent in nature and also that they affected the infant psychologically for the foreseeable future.
