Re: Authority for the County of Westchester to enter into a film permit agreement with Carrier Productions LLC to utilize locations at the Westchester County Airport to film scenes for the television program entitled "The Diplomat", from February 9, 2026 through February 11, 2026, for an estimated permit fee of \$65,125.00, to be paid to the County.

Authority is respectfully requested from your Honorable Board for the County of Westchester (the "County"), acting by and through its Office of Tourism & Film ("Film Office"), to enter into a film permit agreement (the "Agreement") with Carrier Productions LLC to utilize locations at the Westchester County Airport to film scenes for the television program entitled "The Diplomat", from February 9, 2026 through February 11, 2026, for an estimated permit fee of \$65,125.00, to be paid to the County. This Agreement will result in revenue for the County and will also promote the County and provide revenue for its local businesses.

This Agreement will serve a public purpose by encouraging film production within the County and promoting local economic development. The goal and objective of the Agreement is to provide locations within Westchester County for film and commercial photography. The goal and objective of the Agreement will be tracked and monitored by the Film Office. This Agreement is in the best interest of the County in terms of fiscal responsibility because the Agreement will increase the County's film permit revenues.

Accordingly, a resolution authorizing the Agreement with Carrier Productions LLC is attached for your Honorable Board's approval.
