SUBJECT: Authority for the County of Westchester to exercise its first option under its agreement with Together for Youth, for services to provide and operate a non-secure juvenile detention site and program for up to four (4) youths, and thereby extend the term of the agreement by one (1) year and increase its authorized not-to-exceed amount by \$863,791.00.

By a resolution approved on December 19, 2024, your Honorable Board authorized the County of Westchester (the "County") to enter into an agreement (the "Agreement") with Together for Youth ("TFY"), pursuant to which TFY was to provide services to provide and operate a non-secure juvenile detention site and program for up to four (4) youths (the "Services"), for an amount not-to-exceed \$841,504.60 for the period from December 31, 2024 through December 31, 2025 (the "Initial Term"), payable for December 31, 2024 at a per-youth per diem rate of \$718.40 and payable in an amount not-to-exceed \$838,631.00 for the calendar year 2025, pursuant to an approved budget, and with the County having the option, in its sole discretion, to extend the term for up to five (5) additional one (1) year periods thereafter on the same terms as the Initial Term (each an "Option Term"), except for different cost terms for each Option Term, with the following respective not-to-exceed amounts for each Option Term, each of which would be payable pursuant to an approved budget:

1.) Option Term #1 (1/1/26 - 12/31/26)	\$863,791.00
2.) Option Term #2 (1/1/27 - 12/31/27)	\$889,703.00
3.) Option Term #3 (1/1/28 - 12/31/28)	\$916,396.00
4.) Option Term #4 (1/1/29 - 12/31/29)	\$943,889.00
5.) Option Term #5 (1/1/30 - 12/31/30)	\$972,154.00

The Agreement was subsequently executed.

The County continues to require the Services. Therefore, the County respectfully requests authority from your Honorable Board to exercise its first option under the Agreement, and thereby, 1.) extend its term by one (1) year, to a new termination date of December 31, 2026, and, 2.) increase its authorized not-to-exceed amount by \$863,791.00, to a new total authorized not-to-exceed amount of \$1,705,295.60, in order to pay for services during the option term, and which additional amount shall be payable as specified in the Agreement (the "First Option-Exercise").

Except as specifically described above, all terms and conditions of the Agreement shall remain in full force and effect.

The proposed First Option-Exercise will serve a public purpose by providing the County, for an additional year, with an appropriate residential facility, and necessary services, that are intended to ensure the health, safety, and well-being of youth requiring non-secure detention.

The goal and objective of the proposed First Option-Exercise is in the best interests of the County in terms of public health and safety, as providing the County, for an additional year, with an appropriate residential facility, and necessary services, that are intended to ensure the health, safety, and well-being of youth requiring non-secure detention, is anticipated to advance public health and safety, overall.

The goal and objective of the proposed First Option-Exercise will be tracked and monitored by the staff of the Department of Probation.

I respectfully recommend the adoption of the attached resolution.

## RESOLUTION

Upon a communication from the Commissioner of Probation, be it hereby:

**RESOLVED**, that the County of Westchester (the “County”) is hereby authorized to exercise its first option under an agreement with Together for Youth (“TFY”), pursuant to which TFY was to provide services to provide and operate a non-secure juvenile detention site and program for up to four (4) youths, for an amount not-to-exceed \$841,504.60 for the period from December 31, 2024 through December 31, 2025 (the “Initial Term”), payable for December 31, 2024 at a per-youth per diem rate of \$718.40 and payable in an amount not-to-exceed \$838,631.00 for the calendar year 2025, pursuant to an approved budget, and with the County having the option, in its sole discretion, to extend the term for up to five (5) additional one (1) year periods thereafter on the same terms as the Initial Term (each an “Option Term”), except for different cost terms for each Option Term, with the following respective not-to-exceed amounts for each Option Term, each of which would be payable pursuant to an approved budget:

1.) Option Term #1 (1/1/26 - 12/31/26)	\$863,791.00
2.) Option Term #2 (1/1/27 - 12/31/27)	\$889,703.00
3.) Option Term #3 (1/1/28 - 12/31/28)	\$916,396.00
4.) Option Term #4 (1/1/29 - 12/31/29)	\$943,889.00
5.) Option Term #5 (1/1/30 - 12/31/30)	\$972,154.00

(the “Agreement”), and thereby, 1.) extend its term by one (1) year, to a new termination date of December 31, 2026; and 2.) increase its authorized not-to-exceed amount by \$863,791.00, to a new total authorized not-to-exceed amount of \$1,705,295.60, in order to pay for services during the option term, and which additional amount shall be payable as specified in the Agreement (the “First Option-Exercise”); and be it further

**RESOLVED**, that except as specifically hereby authorized to be modified by the First Option-Exercise, all terms and conditions of the Agreement shall remain in full force and effect; and be it further

**RESOLVED**, that the County Executive or his duly authorized designee is hereby authorized to execute any documents and take any actions reasonably necessary and appropriate to effectuate the purposes of this resolution.
