On June 26, 2024, the County of Westchester ("County") received and opened four (4) bids for Contract No. 17-514 Rehabilitation of Cove Road and Edgewater Point Pumping Stations, Mamaroneck Sanitary Sewer District, Mamaroneck, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that Mace Contracting Corporation (MBE) submitted the low bid in the amount of \$5,763,000.00.

The low bidder has been investigated and it has been found that Mace Contracting Corporation (MBE):

X Performed satisfactory work in the past for the County.

The objective of this contract is to prevent failure, including the occurrence of a sewage overflow emergency that could allow sewage into the surrounding properties and cause violations of the pumping station's State Pollutant Discharge Elimination System ("SPDES") Permit.

The contract will benefit the public as it will ensure that the facility's operations are safe and environmentally compliant, thereby enhancing the health and general welfare of the residents of Westchester County.

The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 17-514 be awarded to Mace Contracting Corporation (MBE) in the amount of \$5,763,000.00.
