SUBJECT: Authority for the County of Westchester to execute an agreement consenting to the assignment of Contract No. 19-926, for engineering services in connection with the Replacement of Bronx River Parkway Bridge (North of Greenacres Avenue) over Bronx River (BIN 3348719), Village of Scarsdale, New York, from Lockwood, Kessler & Bartlett, Inc. to LKB Engineering PLLC, effective upon execution of the assignment agreement.

By resolution approved on October 24, 2019, your Honorable Board authorized the County of Westchester (the "County"), acting by and through its Department of Public Works and Transportation (the "Department"), to enter into an agreement (Contract No. 19-926; the "Agreement") with Lockwood, Kessler & Bartlett, Inc., One Aerial Way, Syosset, New York 11791 ("Lockwood"), pursuant to which Lockwood agreed to provide engineering services for the Replacement of Bronx River Parkway Bridge (North of Greenacres Avenue) over Bronx River (BIN 3348719), Village of Scarsdale, New York (the "Project"), to be completed no later than December 31, 2024, for an amount not-to-exceed \$922,000.00, payable pursuant to an approved budget. The Agreement was subsequently executed.

Thereafter, by resolution approved on February 1, 2024, your Honorable Board authorized the County to amend the Agreement (the "First Amendment") in order to: i) expand the scope of services to provide for additional engineering services in connection with the Project that were required to address additional tasks that had been identified which were not included in the Agreement; ii) increase the not-to-exceed amount by an additional amount not to exceed \$182,255.00, from an amount not-to-exceed \$922,000.00, to a new total aggregate not-to-exceed amount of \$1,104,255.00; and iii) extend the completion date set forth in the Agreement from December 31, 2024 to December 31, 2028. The First Amendment was subsequently executed.

By letter dated October 20, 2025, Lockwood informed the Department that it had divested its design engineering operations to LKB Engineering PLLC, One Aerial Way, Syosset, New York 11791 ("LKB") and requested that the County consent to the assignment of the Agreement to LKB (the "Assignment Agreement"). Accordingly, authority is hereby requested of your Honorable Board to authorize the County to consent to the assignment of the Agreement, from Lockwood to LKB, effective upon execution of the Assignment Agreement by all parties and approval of same by the Office of the County Attorney.

All other terms and conditions of the Agreement, shall remain in full force and effect.

Accordingly, your favorable action on the annexed Resolution is most respectfully urged and recommend.

RESOLVED, that the County Executive or his duly authorized designee is hereby authorized and empowered to execute any and all documents necessary or appropriate to effectuate the purposes hereof.
